September Drug Tariff News

Additions to Part 8a

38 items have been added to Part 8a in the September Drug Tariff. Products which you may find of interest are:

Follitropin alfa solution for injection pre-filled disposable devices (all strengths) have been added to the September Drug Tariff, depending on the strength, the reimbursement price is either based on Bemfola or Gonal-f.

Melatonin 3mg tablets pack size 30 have gone into the September Drug Tariff with the reimbursement based on Colonis Pharma Ltd at £65.00. Checking mainline and short line wholesalers, currently the purchase price is also £65.00.

Paracetamol 1g effervescent tablets sugar free are now in the Drug Tariff with the reimbursement price based on Altridexamol.

Simeticone 40mg/ml oral suspension sugar free pack size 55ml and 85ml have gone into the drug tariff, with the reimbursement price based on Infacol. The 50ml pack size has been removed so if you have 50ml remaining on your dispensary shelf, you will need to endorse the pack size and price you have paid in the left-hand column. Moving forward ensure that either 55ml or 85ml are prescribed and dispensed.

Methoxy polyethylene glycolepoetin beta solution for injection pre-filled syringes (all strengths) are now in the tariff with the reimbursement price based on Mircera.

All of the above are now in the Drug Tariff so any generically written prescription will need no extra endorsement as prescription services now have a price to pay you.

Deletions to Part 8a

Simeticone 40mg/ml oral suspension sugar free 50ml has been deleted however 2 more pack sizes have been added.

Hydrocortisone 1% / Urea 10% cream pack sizes 30g and 100g have been removed from Part 8a. No other pack sizes are listed.

Alverine 60mg / Simeticone 300mg capsules have been removed from the drug tariff.

(Please be aware that any items deleted from Part 8a, is still allowed on FP10. However, if you were to dispense one of these items, you would need to endorse the manufacturer, pack size and price in the left-hand column).

Other Changes to Part 8a

Atomoxetine capsules (all strengths) have gone from a Category C to a Category A. This tells us the product is now generically available. The reimbursement has dropped slightly but you can purchase the generics much cheaper, giving you a healthy profit margin.

Prednisolone sodium phosphate 0.5% ear/eye drops is still sitting as a Category C but the reimbursement price is now based on RPH Pharmaceuticals instead of Predsol Ear/Eye drops. This is an interesting one as last month it was on the August concession Price list.

September Horizon Scanning

- Mentioned this last month but DDS are still coming across practices who
 haven't actioned this. Solifenacin 10mg and 5mg tablets recently came off
 patent. However, they are still sitting as a Category C in the Drug Tariff and
 you are still being reimbursed for the Vesicare brand. You can now however
 purchase the generic for as little as £4.00.
- Melatonin 5mg/5ml oral solution and Melatonin 5mg/5ml oral suspension have been removed from Part 8b. There is now an alternative product which can be found in Part 8a.
- Maybe a little late in the season but any prescriptions for Sodium Cromoglicate eye drops, the most profitable way to dispense is to prescribe the item generically(13.5ml) and dispense Opticrom.
- Hormone replacement therapy (HRT) supply issues- Evorel Conti and Evorel Sequi are expected to go out of stock mid-September- for guidance on prescribing please visit the DDA website for 'Supply Interruptions Notification' to check what is currently available.
- New Oxypro deal available from Ridge Pharma 15% discount from pack 1 on all strengths of Oxypro prolonged-release tablets - please contact Ridge Pharma for more details.



The above list are items which you may be purchasing above Drug Tariff price. For more information on how to deal with generics above Drug Tariff, please contact DDS directly as any amendment on the prescription has to be carried out using net pricing.

FAQ

- If we are amending a prescription in the main body to state a brand dispensed, do we need to add the price in the left hand column?
- No DMD (Dictionary of Medicines and Devices) will have details of prices of most brands.
- We are trying to check our Wrong Group Movements but can only see June 19, is this correct?
- Yes, the Wrong Group Movements will be approx. 2 3 months in arrears.
- We have a G.P who is wanting to start a LARC clinic (Long-acting reversible contraceptive)- do we get a discount on the Mirena coil?
 No there is no wholesaler discount or Manufacturer discount scheme for the Mirena coil. If you G.P is insistant you could ask the patient to get the appliance dispensed at a local chemist and bring the appliance with them or some shortliners can provide Parallel import.
